The United States of America, acting through the Millennium Challenge Corporation ("MCC") and the Government of Malawi (the "Government") have entered into a second Millennium Challenge Compact for Millennium Challenge Account assistance to help facilitate poverty reduction through economic growth in Malawi (the "Compact") in the amount of Three hundred fifty million U.S. Dollars [US\$350,000,000] ("MCC Funding"). The Government, acting through the Malawi Millennium Development Trust (the "[MMD]"), intends to apply a portion of the MCC Funding to eligible payments under a contract for which this Request for Applications ("RFA") is issued.
