The United States of America, acting through the Millennium Challenge Corporation (“MCC”) and the Government of **Malawi** (the “Government”) have entered into a second Millennium Challenge Compact for Millennium Challenge Account assistance to help facilitate poverty reduction through economic growth in **Malawi** (the “Compact”) in the amount of **Three and hundred fifty million U.S. Dollars [US\$350,000,000]** (“MCC Funding”). The Government, acting through **the Malawi Millennium Development Trust (the “MMD”)**, intends to apply a portion of the MCC Funding to eligible payments under a contract for which this Request for Applications (“RFA”) is issued.

MMD hereby invites individual Consultants eligible to provide consultancy services as Technical Evaluation Panel (TEP) Members for the below expertise to evaluate proposals that will be submitted in response to the various Request for Proposals (RFPs) to be issued for the procurements of the AGC Project.
