The United States of America, acting through the Millennium Challenge Corporation (MCC), and the Government of Malawi (the Government) signed the following two agreements:

- a) a Compact Development Funding Grant Agreement, pursuant to which MCC agreed to provide a grant of up to US\$11,650,000 to the Government to facilitate development of a compact program; and
- b) A Compact Agreement under which MCC agreed to provide a grant of US\$350,000,000 to the Government to support the execution of a number of preparatory activities leading to Entry Into Force (EIF) of the Compact and after EIF, to fund the implementation of the various activities under the program..

The Government has designated the Malawi Millennium Development Trust (MMD) to implement the Government's responsibilities under the Agreement and intends to apply part of the funds to payments for contracts for Goods and Services.

MCC has contracted Crown Agents to perform Interim Procurement Agent Services on behalf of the Government, for the procurements to be funded by the Grant and Implementation Agreement.
